# Industrial Battery Warranty

## WARRANTY – Gel Tubular Battery

### Warranty – Conventional Charging

Exponential Power, Inc. warrants to the original user, subject to the conditions described below, that all 9–33 plate Exponential Power, Inc. batteries will be free from defects in material and workmanship for three (3) year full and two (2) years prorated (GEL Tubular). EXCEPTIONS to this warranty: Individual cells are warranted for one (1) year. If a defect is found during the warranty coverage period as listed above, or if the battery fails to deliver 80% of the rated capacity at the six (6) hour amp hour rating, Exponential Power, Inc., or one of its designated service representatives, will repair or replace the battery with one of equal to or greater Amp Hour capacity to the original owner. All repair or replacement transportation costs, rental charges, etc. are the responsibility of the original owner. The repaired or replacement battery shall be warranted for the remainder of the original battery warranty period. If replaced, the original battery will become the property of Exponential Power, Inc. If the battery is under the prorate warranty period Exponential Power, Inc. will credit the original owner toward the purchase of a new replacement Exponential Power, Inc. battery. If the user believes warranty service is required, the user should notify Exponential Power, Inc. in writing within the warranty period.

### Conditions of Warranty

This warranty is conditioned upon the following:

- 1) Exponential Power, Inc. and end user mutually agree that the battery meets the size and capacity requirements for lift truck's intended duty cycle. At Exponential Power's discretion the warranty may be voided if the duty cycle performed is in excess of the original intended duty cycle.
- 2) Battery must be charged on an Exponential Power, Inc. supplied or approved charger of PROPER CAPACITY, voltages, and charging rate to fully charge battery before next discharge cycle begins. Proper operation of charger must be checked at least every six (6) months and recorded accordingly.
- 3) The battery is limited to one (1) cycle (charge and discharge) per 24-hour period and 300 cycles per year.
- 4) The daily depth of discharge must be limited to 60% discharge state.
- 5) This warranty is voided if the CELL TEMPERATURE is routinely allowed to drop below 45°F or exceed 110°F.
- 6) Battery must be maintained according to operating instructions included with the battery when delivered. Records of daily maintenance and operation of the battery must be recorded and available for inspection by Exponential Power, Inc. upon request. This warranty is voided if battery is subject to misuse, abuse, or physical damage beyond normal usage.
- 7) User agrees that the manufacturer's representative may have access to equipment furnished hereunder for purpose of inspection at reasonable hours and intervals.
- 8) Manufacturer assumes no responsibility for any work done or expense incurred except for those authorized by manufacturer.
- 9) Repair work performed by anyone other than an Exponential Power, Inc. authorized service provider will void this warranty.

10) This warranty is valid to the ORIGINAL USER only and is not transferable.

### Limitations

The provisions of this warranty shall not apply for failure due to misuse, negligence, or an accident, including, but not limited to, improper watering, charging, discharging, installation, freezing, fire, collision, or use of improper electrolyte other than recommended by Exponential Power, Inc., repairs other than by Exponential Power, Inc. or its designated representative, or any other change from acts or conditions beyond the control of Exponential Power, Inc. Exponential Power's sole obligation and the original user's exclusive remedy under this warranty shall be for repair or replacement as described above. In addition, Exponential Power, Inc. shall not be liable for any removal or installation expense, or the loss of time or profits. User assumes responsibility for all personal injury and property damage resulting from the handling, possession or use of the battery. All other warranties, whether statutory, expressed or implied, including, but not limited to, implied warranties of merchantability and fitness for a particular purpose, are disclaimed. In no event shall Exponential Power, Inc. be liable for any accidental or consequential damages. In no event shall the liability of Exponential Power, Inc. for any and all claims exceed the purchase price of the battery.
